- 5. Proof of remittance of fees should be sent to Assistant Registrar, MGAHV, Wardha.
- 6. No fee is to be paid by the SC/ST/Physically handicapped/women candidates and in service candidates of MGAHV, Wardha.
- 7. Separate Application along with application fee should be submitted for each post applied for.
- 8. Relaxation in age limit may be allowed to SC/ST/OBC/PWD candidates and employees working in central/State/University/Autonomous Bodies etc. in accordance with the instructions/guidelines/ orders issued by the Govt. of India from time to time in this regards.
- 9. SC/ST/OBC (non-creamy layer) category candidates should submit Caste Certificate (Self attested copy) in the proforma prescribed by the Govt. of India.
- 10. A relaxation of 5% shall be provided, from 55% to 50% of marks at the master's level for the SC/ST/PWD Category, wherever applicable.

- A relaxation of 5% shall be provided, from 55% of the marks to the Ph.D. degree holders who have passed their Master's degree prior to 19th Sept. 1991, wherever applicable.
- 12. 'B' Grade in the Seven point Scale with grades O, A, B, C, D, E, & F shall be regarded as equivalent of 55% where the grading system is followed.
- 13. Application from candidates working in Govt. Department, Autonomous bodies, Public Sector undertakings, Universities etc. will be considered only, if application forwarded through proper channel certifying that no vigilance/disciplinary proceeding is pending or contemplated against the applicant. However, the application may be submitted online in advance before the closing date. In such cases NOC from the employer must be produced at the time of interview.
- 14. If at any time before or after the selection of a candidate, it is found that any information is false or suppressed, his/her selection will be liable to be cancelled.
- 15. The qualifications prescribed should have been obtained from recognized University/Institution. Educational qualification and age limit shall be reckoned as on closing date of the application.
- 16. Applicants will be required to enclose attested/self attested copies of the all certificates of their educational qualifications, experience etc.
- 17. No T.A./D.A. will be paid to the Gen/OBC candidates, However, outstation SC/ST candidates called for interview will be paid 2nd class (sleeper class) Railway fare from the place of duty/residence to Wardha (MS) and back by the shortest route on production of tickets.
